

CO-FOUNDER NEEDED

Al-powered energy optimization for industry.

PUREON ENERGY

THE PROBLEM

Industries face rising energy costs, increasing CO_2 reduction requirements, and lack intelligent tools to optimize and automate their energy consumption in a volatile electricity market.

OUR SOLUTION

We solve this by using our AI engine, Quantum, which optimizes industrial energy use in real time through our hardware device (Pulse) and aggregates flexibility for the grid via Nexus.

PATENT STATUS

We have not filed any patents at this stage. Our core advantage lies in proprietary algorithms, specialized know-how, and integration expertise.

FINANCIAL OVERVIEW

Pureon Energy generates revenue through a SaaS-based model combined with hardware sales. Our product *Pulse* is sold as a hardware unit with a recurring subscription fee for Al optimization services, while *Nexus* provides transaction-based revenues from flexibility aggregation with balance responsible parties. We have applied for a *Innofounder* to support our early-stage growth and product scaling. Key financial milestones include securing initial recurring revenue streams from pilot customers, expanding to 10+ industrial sites within the next 18 months, and reaching break-even within 3-4 years. Launis A/S and Idealcombi A/S is the current signed on pilot project. Major cost factors are salaries (Al/loT engineers, sales team), small costs to hardware. With a scalable SaaS model and strong industrial demand, we see significant growth potential across the Nordics and Europe.

MILESTONES ACHIEVED

Developed our proprietary Al engine (Quantum) and launched products Pulse and Nexus. Secured a pilot with Launis A/S to validate technology in industry. Idealcombi A/S has had the implemtation for a year, and reduced their energy costs by 34% (~750.000DKK). Built strong founder team combining energy informatics and business expertise (Søren Thisted and Bo Petersen). Applied for Innofounder funding to support early growth. Established initial partnerships with industrial stakeholders and energy market players.

TARGET MARKET & CUSTOMERS

We build for industrial companies with high energy consumption, helping them reduce costs and CO₂ emissions through automation. Our market focus is the Nordic and European industrial sector, as well as energy companies and balance responsible parties seeking flexibility services.
